TERMS:

1. All submissions must be suitably prepared for exhibition. The Kuskokwim Art Guild (KAG) and Yupik Museum (YM) have pedestals and tables available to display sculpture. The KAG & YM's commission on sale of art pieces will be 25% of the sale price.
2. KAG & YM will collect and pay Bethel sales tax% 06 on art sold during the exhibition. Artist payments will be made at the conclusion of the show within 30 days. All work must remain on display in the gallery through the final exhibition date.
3. KAG and YM will insure the work on location during the period of the loan, provided this form is signed. The lender agrees that in the event of loss or damage, recovery shall be limited to such amount, if any, as may be paid by the insurer, hereby releasing the KAG, YM and UAF YP Cultural Center, officers, agents and employees of KAG, YM, and UAF YP Cultural Center from liability for any and all claims arising out of such loss or damage.
4. KAG and YM will provide a free public reception and closing events.
5. Advance publicity will be provided in local media and KAG and YM mailings, Facebook, posters and press releases.
